

#### **DEFINITIONS**

**Type "A"** permits allow a one-inch or smaller connection to the hydrant for short-term construction, demolition or landscape activities. Meters are not issued with type "A" permits. Type "A" permits are billed a monthly administrative fee and a flat daily fee, based on rates outlined in the fee table below. Applicants must make use of their own <u>backflow prevention device</u> and submit approved testing results of their device.

**Type "B"** permits allow a valve connection to the hydrant to fill water trucks or tanks. This water may be used for construction, street or parking lot cleaning, landscape spraying or other similar uses. Type "B" permits are billed a monthly administrative fee and a flat daily fee, based on the rates outlined in the fee table below. **NOTE:** All trucks and tanks must be inspected and have an air gap at the filling point or must meet <u>backflow prevention</u> requirements before permits are valid.

**Type "C"** permits allow a metered connection to the hydrant. Type "C" permits are for use with hose or piping larger than one inch and/or any other uses not classified as type "A" or "B". After the paperwork is completed for the type "C" permit, the hydrant meter must be picked up from the City's Maintenance Operations Center. Applicants must make use of their own <u>backflow prevention</u> <u>device</u> and submit approved testing results of their device. Type "C" permits are billed a monthly administrative fee, flat daily fee and a commodity charge based on water usage reported. The permit holder is required to report a monthly meter reading to the Development Services Center for invoicing purposes. **NOTE:** Type "C" permits are contingent on meter availability.

### 13.16.30 HYDRANT USE CHARGES

Deposits shall be required for all Hydrant Use Permits. Hydrant Use Permit charges include daily and monthly fees and commodity charges when metered in accordance with the following schedule. Based on Service Area:

**REDMOND SERVICE AREA:** Roughly, the area east of 132nd Avenue N.E., south of N.E. 124th Street, west of 196th Avenue N.E., north of N.E. 20th Street, and specifically excluding Marymoor Park and Lake Sammamish

## **HYDRANT USE AND CANCELLATION POLICY**

Hydrant permits are sold for short-term water for construction, demolition, landscape, and other special water uses. For commercial use, applicants must have a City of Redmond business license to obtain a permit. Hydrant permits are sold over the counter in the Development Services Center located on the 2nd floor of City Hall, 15670 NE 85th Street, and are readily available with the payment of the required deposit (Cash or Check Only), completion of the permit application form, and submittal of the approved testing certification of your backflow prevention device. Fees information: Hydrant Use Permits

WRITTEN NOTIFICATION is required to cancel or close your permit
