I. RECOMMENDED ACTION:

Approval of award of bid for the Downtown Redmond Crosswalk Upgrade, Project No. 101440, to Apply-A-Line., Inc. of Pacific, Washington, for the bid amount of \$109,999 and authorize the Mayor to sign the contract.

III. DESCRIPTION:

The Downtown Redmond Crosswalk Upgrade project will improve pedestrian safety by upgrading crosswalks at nineteen signalized intersections in downtown Redmond to a safer piano-style (ladder bar) crosswalk design. The attached vicinity map shows street locations of the crosswalks that will be upgraded.

This project is identified in the 2010-2015 Transportation Improvement Program as project S45. The City received a Federal Highway Safety Improvement Program (HSIP) grant to upgrade the 19 downtown intersections in February 2009, the design work for this project was performed by City staff.

The project was advertised in the Seattle Daily Journal of Commerce on May 19, 2010, and May 26, 2010. The City Clerk received bids until 2 p.m., June 10, 2010. There were two bidders and the bid totals are summarized below:

Staff recommends award to Apply-A-Line, Inc., the low responsible bidder. Apply-A-Line has successfully performed numerous projects for the City.
