## RESOLUTION NO. 1150

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF REDMOND, WASHINGTON AUTHORIZING APPLICATION FOR FUNDING ASSISTANCE FOR A 2002 WASHINGTON WILDLIFE AND RECREATION PROGRAM (WWRP) PROJECT, THE PERRIGO COMMUNITY PARK, TO THE INTERAGENCY COMMITTEE FOR OUTDOOR RECREATION (IAC) AS PROVIDED IN CHAPTER 79A.15 RCW, ACQUISITION OF HABITAT CONSERVATION AND OUTDOOR RECREATION LANDS.

WHEREAS, the City Council of the City of Redmond, Washington has approved a comprehensive parks plan, the Parks, Recreation and Open Space Plan (PRO Plan), that includes this project area; and

WHEREAS, the City Council of the City of Redmond, Washington has approved the Avondale Area Community Park master plan (officially named Perrigo Community Park); and

WHEREAS, under the provisions of the Interagency Committee for Outdoor Recreation (IAC), Washington Wildlife and Recreation Program, funding assistance is requested to aid in financing the cost of land acquisition; and

WHEREAS, the City of Redmond considers it in the best public interest to complete the land acquisition described in the application.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF REDMOND, WASHINGTON HEREBY RESOLVES AS FOLLOWS:

Section 1. The Mayor is hereby authorized to make formal application to the IAC for funding assistance for the acquisition of the Hanscom property;

Section 2. Any funding assistance received as the result of this application shall be used for implementation of the park project referenced above;

Section 3. The City of Redmond hereby certifies that its share of project funding is committed and will be derived from City of Redmond Capital Investment Program funds and/or impact fee funds and/or Redmond 1989 Bond funds;

The City of Redmond acknowledges that any property Section 4. acquired with IAC financial aid must be placed in use as an outdoor recreation facility and be retained in such use in perpetuity unless otherwise provided and agreed to by the Redmond City Council and IAC;

Section 5. This Resolution shall become part of a formal application to IAC;

The City of Redmond has provided appropriate opportunity Section 6. for public comment on this application.
