CITY OF REDMOND ORDINANCE NO. 2565

AN ORDINANCE OF THE CITY OF REDMOND, WASHINGTON, AMENDING RMC 13.16.010(A)(1), TO AMEND THE DEFINITION OF SINGLE-FAMILY RESIDENTIAL; AMENDING RMC 13.16.020, 13.16.030, AND 13.16.040, INCREASING WATER, HYDRANT, AND SEWER RATES AND CHARGES; AND PROVIDING FOR SEVERABILITY, AND ESTABLISHING EFFECTIVE DATES

WHEREAS, all costs to operate and maintain the water and sewer systems continue to increase because of general escalation of costs; and

WHEREAS, conservation has continued to decrease the amount of water use thereby lowering the amount of sewage generated from a residential home; and

WHEREAS, the usage of water during the summer extends through September.

NOW THEREFORE, THE CITY COUNCIL OF THE CITY OF REDMOND, WASHINGTON, DO ORDAIN AS FOLLOWS:

Section 1. Classification. Sections 2, 3, 4, and 5, of this ordinance are of a general and permanent nature and shall become a part of the City Code. Sections 1, 6, and 7 are noncode.

Section 2. Amendment of paragraph. RMC 13.16.010(A)

(1), Definitions, is hereby amended to read as follows:

- A. Use Classifications.
- 1. Single-Family Residential. Singlefamily residential shall include:
- a. One single-family dwelling served by a single meter; or
- b. One single-family dwelling which includes an accessory dwelling unit [WITHIN THE DWELLING], served by a single meter; or
- c. One common wall single-family unit served by a single meter.

Accessory single-family structures including, but not limited to, garages, greenhouses, cabanas, workshops with plumbing, etc., shall be incidental uses to single-family residential and shall not cause a change in classification to multi-family residential or commercial.

Service Rates and Charges, is hereby amended to read as follows:

A. Water service charges shall include a fixed monthly charge and a commodity charge. The fixed monthly charge shall apply to each meter. The commodity charge may vary with consumption depending upon classification, and shall apply to each meter.

The commodity charge rate shall be per 100 cubic feet and may be prorated for fractional parts of 100 cubic feet. The charges vary by service area and by season. Summer commodity charges shall apply for all service for which a billing statement is prepared starting June 1st and ending [SEPTEMBER 30TH] October 31. Water service rates and charges shall be in accordance with the following rate schedules:

Section 5. Amendment of section. RMC 13.16.040, Sewer service rates and charges, is hereby amended to read as follows:

A. Single-Family Residential. Sewer rates and charges for single-family residential shall include two components, a Redmond collection component and a

King County Wastewater Treatment component. Redmond collection component for the Redmond Service Area shall be a monthly rate of [\$12.29] \$12.32 per single-family residential connection in [2009] 2011 [\$12.32] \$12.57 per single-family residential connection in [2010] 2012 and after. The Redmond collection component for the Novelty Hill Service Area shall be a monthly rate of [\$20.96] \$29.02 per singlefamily residential connection in $[\frac{2009}{}]$ 2011 per single-family residential [\$22.86] \$29.02 connection in [2010] 2012 and after. The King County Wastewater Treatment component shall be a monthly rate and shall be equal to the residential rate set by King County.

B. Multi-Family Residential. Sewer rates and charges for multi-family residential shall include two components, a Redmond collection component and a King County Wastewater Treatment component. The Redmond collection component for the Redmond Service Area shall include a base charge of [\$14.97 PER MONTH FOR 2009 WHICH SHALL INCLUDE THE FIRST 750 CUBIC FEET OF CHARGEABLE WASTEWATER, PLUS A COMMODITY CHARGE OF \$1.28 PER 100 GUBIC FEET OF CHARGEABLE WASTEWATER OVER

THE FIRST 750 CUBIC FEET; AND A BASE CHARGE OF | \$15.08 per month for [2010 AND AFTER] 2011, which shall include the first [700] 650 cubic feet of chargeable wastewater, plus a commodity charge of [\$1.37] \$1.45 per 100 cubic feet of chargeable wastewater over the first [700] 650 cubic feet; and a base charge of \$15.38 per month for 2012 and after, which shall include the first 650 cubic feet of chargeable wastewater, plus a commodity charge of \$1.48 per 100 cubic feet of chargeable wastewater over the first 650 cubic feet. The Redmond collection component for the Novelty Hill Service Area shall include a base charge of [\$25.50 PER MONTH FOR 2009 WHICH SHALL INCLUDE THE FIRST 750 CUBIC FEET OF CHARGEABLE WASTEWATER, PLUS A COMMODITY CHARGE OF \$2.20 PER 100 CUBIC FEET OF CHARCEABLE WASTEWATER OVER THE FIRST 750 CUBIC FEET; AND A BASE CHARGE OF \$27.85] \$35.40 per month for [2010 AND AFTER] 2011, which shall include the first [700] 650 cubic feet of chargeable wastewater, plus a commodity charge of [\$2.55] \$3.48 per 100 cubic feet of chargeable wastewater over the first [700] 650 cubic feet; and a base charge of \$35.40 per month for 2012 and after, which shall include the first 650

cubic feet of chargeable wastewater, plus a commodity charge of \$3.48 per 100 cubic feet of chargeable wastewater over the first 650 cubic feet. The King County Wastewater Treatment component shall be the King County residential equivalent rate converted to a commodity charge per 100 cubic feet of chargeable wastewater, except that the minimum King County Wastewater Treatment component shall be equal to the amount for a single-family equivalent per month per meter. Each meter within an account shall be subject to the minimum monthly charges.

C. Commercial. Sewer rates and charges for commercial shall include two components, a Redmond collection component and a King County Wastewater Treatment component. The Redmond collection component for the Redmond Service Area shall include [A BASIC MONTHLY CHARGE OF \$14.97 PER MONTH FOR 2009, WHICH SHALL INCLUDE THE FIRST 750 CUBIC FEET OF CHARGEABLE WASTEWATER, PLUS A COMMODITY CHARGE OF \$1.28 PER 100 CUBIC FEET OF GHARGEABLE WASTEWATER OVER THE FIRST 750 CUBIC FEET; AND] a base charge of \$15.08 per month for [2010 AND AFTER] 2011, which shall include the first [700] 650 cubic feet of chargeable wastewater, plus a

commodity charge of [\$1.37] \$1.45 per 100 cubic feet of chargeable wastewater over the first [700] 650 cubic feet; and a base charge of \$15.38 per month for 2012 and after, which shall include the first 650 cubic feet of chargeable wastewater, plus a commodity charge of \$1.48 per 100 cubic feet of chargeable wastewater over the first 650 cubic feet. The Redmond collection component for the Novelty Hill Service Area shall include a base charge of [\$25.50 PER MONTH FOR 2009, WHICH SHALL INCLUDE THE FIRST 750 CUBIC FEET OF CHARGEABLE WASTEWATER, PLUS A COMMODITY CHARGE OF \$2.20 PER 100 CUBIC FEET OF CHARGEABLE WASTEWATER OVER THE FIRST 750 CUBIC FEET; AND A BASE CHARGE OF \$27.85] \$35.40 per month for [2010 AND AFTER] 2011, which shall include the first [700] 650 cubic feet of chargeable wastewater, plus a commodity charge of [\$2.55] \$3.48 per 100 cubic feet of chargeable wastewater over the first [700] 650 cubic feet; and a base charge of \$35.40 per month for 2012 and after, which shall include the first 650 cubic feet of chargeable wastewater , plus a commodity charge of \$3.48 per 100 cubic feet of chargeable wastewater over the first 650 cubic feet. The King County Wastewater

Treatment component shall be the King County residential equivalent rate converted to a commodity charge per 100 cubic feet of chargeable wastewater, except that the minimum King County Wastewater Treatment component shall be equal to the amount for a single-family equivalent per month per meter. Each meter within an account shall be subject to the minimum monthly charges.

- D. Other. Sewer rates and charges for other uses which do not have a metered water supply such as, but not limited to, parking garages, dumpsters/compactors, gasoline station pump islands, surface drains, etc., shall be at the commercial rate in subsection (C) above. The Public Works Director or designee may establish a monthly estimate of the quantity of wastewater that is considered chargeable wastewater depending on the use being connected. individual use shall be subject to minimum monthly charges as though it was a metered use.
- E. Cooling Tower. Sewer rates and charges for cooling towers shall be the same as commercial except that chargeable wastewater shall be 15 percent of the metered water supply.

F. Billing Period. The monthly and commodity rate for the King County Wastewater Treatment component for the entire billing period shall be the King County rates in effect on the billing date.

Section 6. Severability. If any section, sentence, clause or phrase of this ordinance should be held to be invalid or unconstitutional by a court of competent jurisdiction, such invalidity or unconstitutionality shall not affect the validity or constitutionality of any other section, sentence, clause or phrase of this ordinance.

Section 7. Effective Date. This ordinance shall take effect and be in full force five days after its passage and publication of a summary or as otherwise provided by law except that:

- Rates designated 2011 rates as set forth in Section 3, Section 4 and Section 5 shall be charged for all service that a billing statement is prepared and mailed to the customer on or after January 1, 2011.
- Rates designated 2012 and after rates as set forth in Section 3, Section 4 and Section 5 shall be charged for all service that a billing

- statement is prepared and mailed to the customer on or after January 1, 2012.
- Rates not designated as 2009 or 2010 rates as set forth in Section 3, Section 4 and Section 5 shall be charged for all service that a billing statement is prepared and mailed to the customer on or after January 1, 2011.
- The rates currently in effect shall continue in effect until the 2011 rates become effective as provided above.
