CITY OF REDMOND ORDINANCE NO. 2691

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF REDMOND, WASHINGTON, AMENDING SUPPLEMENTAL "S-PS" PAY PLAN IN ORDER TO SET SUPPLEMENTAL SALARIES FOR REDMOND POLICE ASSOCIATION REPRESENTING POLICE SUPPORT FOR THE YEAR 2013

WHEREAS, Resolution No. 1142, subsequently amended by Resolution No. 1358, calls for an adjustment of salaries in keeping with changes in salaries in the local labor market of both private and municipal employers; and

WHEREAS, these changes should now be reflected by amending the supplemental S-PS Pay Plan for supplemental police support employees.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF REDMOND, WASHINGTON, DO ORDAIN AS FOLLOWS:

Section 1. Pay Plan S-PS. The Supplemental Pay Plan S-PS, covering supplemental police support employees, is hereby adjusted to reflect pay ranges that represent 80 percent to 110 percent of the lowest pay for a comparable Regular Position, as adopted by Ordinance No. 2690, for the RPA - police support bargaining unit. The amended Pay Plan is attached as Exhibit 1 and incorporated herein as if set forth in full.

Section 2. Pay Plan Effective Date. The effective date of the adjusted pay plan will continue to be January 1, 2013, as established by Ordinance No. 2681. The adjusted pay

plan does not result in any retroactive adjustment to the salary of any employee covered by the plan.

Section 3. Severability. If any section, sentence, clause or phrase of this ordinance should be held to be invalid or unconstitutional by a court of competent jurisdiction, such invalidity or unconstitutionality shall not affect the validity or constitutionality of any other section, sentence, clause or phrase of this ordinance.

Section 4. Effective Date. This ordinance shall take effect five days after its publication, or publication of a summary thereof, in the City's official newspaper, or as otherwise provided by law.
