

AMENDMENT #3**TO AGREEMENT FOR INMATE HOUSING**

This AMENDMENT to INTERLOCAL AGREEMENT FOR INMATE HOUSING (hereinafter "Agreement") is made and entered into by and between the South Correctional Entity, a governmental administrative agency formed pursuant to RCW 36.34.030(3) ("SCORE") and the City of Redmond, a government municipality organized under the laws of the State of Washington (hereinafter the "CITY", and together with SCORE, the Parties" or individually "Party").

This AMENDMENT #3 is entered into on 8/24, 2016 between the CITY OF REDMOND, WASHINGTON (the "CITY") and South Correctional Entity ("SCORE"). This amendment is, therefore, attached to and made part of the Agreement for Inmate Housing, city contract #7512 entered into and executed on April 14, 2014 (ORIGINAL AGREEMENT), first amended on February 5, 2015 (city contract 7512-1) and subsequently amended on September 16, 2015 (city contract 7512-2) by the parties identified above.

The Parties hereto mutually agree as follows:

1. **Bed Rate.** Section 27 of the Original Agreement is hereby amended to include the following guaranteed number of beds for inmate housing:

2016 Guaranteed Bed Rate:	\$105
2016 Non-Guaranteed Bed Rate:	\$157
2017 Guaranteed Bed Rate:	\$108.78
2017 Non-Guaranteed Bed Rate:	\$162.65

The City hereby modified its guarantee from 7 to 20 beds.

Duration of Agreement. Section 32 of the Original Agreement is hereby amended to read: The duration of this Agreement shall be from February 1, 2014, at 12:00 A.M. and shall end at 11:15 P.M., on December 31, 2017 unless otherwise terminated in accordance with Section 35 of the ORIGINAL AGREEMENT. This agreement may be renewed for any successive period by written addendum under the same terms and conditions. However, upon such renewal, by mutual agreement of both parties, the Bed Rate fees may be adjusted ...

Should the City exercise the option to extend this agreement, the City may negotiate a price reduction/increase for subsequent terms. Any price adjustment will be in accordance with the most recently published Consumer Price Index (CPI-U) for all urban areas. 2. **Effective Date; Execution.** The bed rates and number of guaranteed beds provided for in Section 1 of this Amendment to the Original Agreement shall become effective upon the date that Amendment #3 is entered into.
3. **Ratification and Confirmation.** All other terms and conditions of the Original Agreement as of the date first mentioned above.
