RESOLUTION NO. 1515**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF REDMOND, WASHINGTON, ADDING NEW USER FEES AND COSTS TO THE CITY PUBLIC WORKS DEPARTMENT SCHEDULE OF FEES CHARGES ASSOCIATED WITH BICYCLE AND SCOOTER SHARING AUTHORIZED UNDER CHAPTER 12.08 OF THE REDMOND MUNICIPAL CODE

WHEREAS, the City Council adopted Ordinance No. 1480 of the City of Redmond which provides that all administrative fees will be set by Council resolution; and

WHEREAS, the City Council adopted Resolution No. 1509 which established a Public Works Department schedule of fees, charges and penalties for various applications submitted to the City for various services and materials provided by the City; and

WHEREAS, the City Council desires to add to the Public Works Department schedule of fees new fees and costs to reflect changes made to Chapter 12.08 of the Redmond Municipal Code regarding cost recovery for bicycle and scooter sharing; and

WHEREAS, the Public Works Director shall determine fees and costs which are adequate to cover the City's costs of providing the services for which the fee, charge or penalty is collected.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF REDMOND, WASHINGTON, HEREBY RESOLVES AS FOLLOWS:

Section 1. Adoption of Fee Schedule. The schedule of fees attached to this resolution as Exhibit A and incorporated herein by this reference as if set forth in full, is hereby adopted as the official fee schedule for the City of Redmond's bike and scooter sharing right-of-way use permit program.

Section 2. Effective Date. This Resolution shall become effective upon adoption
