Challenges:

The City of Redmond has been maintaining the Redmond Senior Center and was planning for a mid-life renovation of the building as part of a 2021 Capital Improvement Project that included roof, HVAC, electrical, plumbing, windows and seismic upgrades for \$15 million. Preliminary assessments indicated water damage in the outer structure of the building. Prior to beginning design work on the planned project, the City hired a structural engineering consultant, HDR, to further evaluate the potential problem. On December 3, 2019, Parks and Recreation Director Carrie Hite delivered the results of the structural engineering assessment to the City Council. HDR recommended that the City continue the vacation of the building due to lack of structural sheathing and support. The damage is likely from the original design, poor construction techniques, or both. The water damage was not visible on inside due to a vapor barrier inside the walls. HDR estimated the cost to renovate the building at \$20 million in 2.5 years, and to rebuild a “like for like” building it would be \$21 million in an estimated 3 years. Opportunities:

The City is planning a public outreach process to provide feedback from the community to the City Council to help them decide how to invest in the Redmond Senior Center. During the outreach process, the City will revisit the outcomes of the [2017 Community Priorities for the Future of Redmond's Community Centers Report](#), where the community affirmed the need for more community center, fitness, and community event spaces. During the community engagement process, between January and February 2020, the community will be asked to evaluate options from renovating the Senior Center, rebuilding like for like, or rebuilding with some type of expansion to include larger spaces or some new amenities.
