



Mechanical Permit Fees

Effective 2.1.2020

A separate mechanical permit is required for each building.

Definition of Valuation: The value of construction shall be based on the value of the work that is being performed. The total value of work shall include materials and labor for which the permit is being sought for. For the construction of new buildings, the building valuation data table located on <https://www.redmond.gov/504/Development-Services-Fees> shall be used for new square footage based off of type of construction and occupancy.

Determination of permit fee: The permit fee for the installation, replacement, relocation or repair of each non-residential or multi-family appliance, ventilation or air-conditioning unit or system or phased work on new systems, is calculated according to the valuation of the work to be done. Fee includes a base fee plus a rate per thousand.

Additional plan review - per hour after 3 rd review.	\$133.12/hour
Additional plan review required by changes, additions or revisions to plans	\$133.12/hour (2-hour minimum; \$266.24)
Alternate Methods and Materials Assessment (AMM)	\$259.57
Permit Re-Activation fee	The fee to recommence work shall be one-half the amount required for a new permit for such work
