## Plumbing Permit Fees

Effective 2.01.2021

**A separate plumbing permit is required for each building.**

**Definition of Valuation:** The value of construction shall be based on the value of the work that is being performed. The total value of work shall include materials and labor for which the permit is being sought for. For the construction of new buildings, the building valuation data table located on <https://www.redmond.gov/504/Development-Services-Fees> shall be used for new square footage based off of type of construction and occupancy.

A 3% technology surcharge will be applied in addition to the listed fee as authorized by Ordinance No. 2090, and extended permanently by Resolution No. 1162 on December 3, 2002.

Permit Re-Activation fee	The fee to recommence work shall be one-half the amount required for a new permit for such work
