Community Workshops

A series of workshops have been scheduled for community discussions on the housing, economic vitality, and transportation options & alternatives and other Redmond 2050 topics. Outreach for the Overlake and Transit-Oriented Development (TOD) updates is also underway, with a series of ‘Equity in our Built Environment’ workshops scheduled for August thru October. Many of these events will be offered as a lunch-and-learn with an evening alternative (same content), and most will be hybrid events with participation in person or online.
