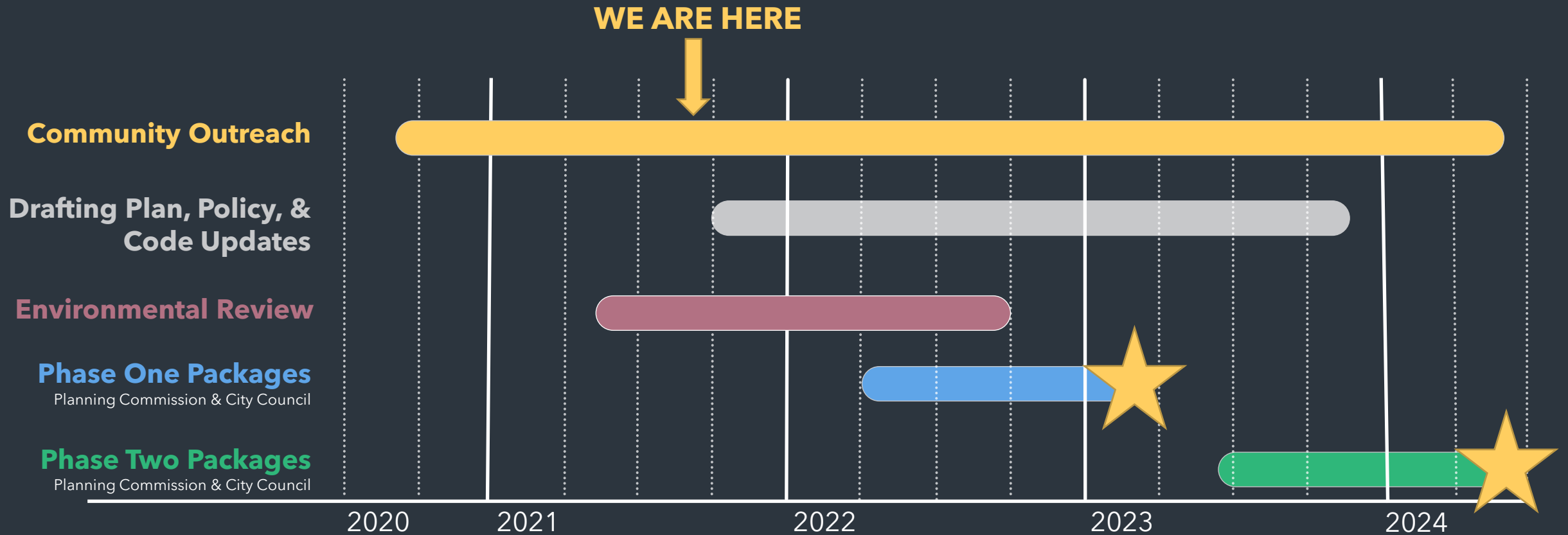

Redmond 2050 Timeline



Phase 1 addresses critical needs, expiring programs, etc.
Plan update must be completed by June 30, 2024

Why Does it Matter?

- Comprehensive Plan must be **internally consistent**
 - Policies may be outdated
 - Policies may be misplaced
 - Policies may introduce other policy considerations not previously identified

Phase 1 Scope and Process

1. List policies related to Phase 1 topics...

(that is, housing, economic vitality, transportation, Overlake, and parks)

...but that are in Phase 2 elements in the Phase 1 Change Matrices

2. Conduct MODRN scan to identify potential conflicts
3. Resolve conflicts in Phase 1 to retain internal consistency

MODRN Scan

Misplaced text

Items that are not in the correct Element

Outdated language and references

Updating terminology, removing policies that are no longer relevant, etc.

Duplicative language

Items that are substantially the same within that Element or with an item in another Element will be combined/updated

Regulatory language

Removing regulations and specific methodology from the Comprehensive Plan and ensuring they're included in the relevant functional plan, codes, etc.

Nonsensical language

Removing or revising language that is unclear or that could be interpreted in more than one way

Summary of Other Element Policies: **Housing**

- 95 related policies
- Most in Neighborhoods Element
- Most common: design, location, types of residential uses
- Specific mandates and restrictions may conflict with updated Housing Element policies



Summary of Other Element Policies: **Economic Vitality**

- 21 related policies
- Mostly Neighborhoods and Land Use Elements
- Manufacturing, mixed-use developments, and ways to support existing businesses.
- Many misplaced or outdated.



Summary of Other Element Policies: **Transportation**

- 135 related policies
- Several elements, with majority in Neighborhoods
- Most common: facility design and specific project priorities
- Specific project priorities could conflict with updated Transportation Element or updated Transportation Master Plan
- Some references to completed projects; can be deleted.
