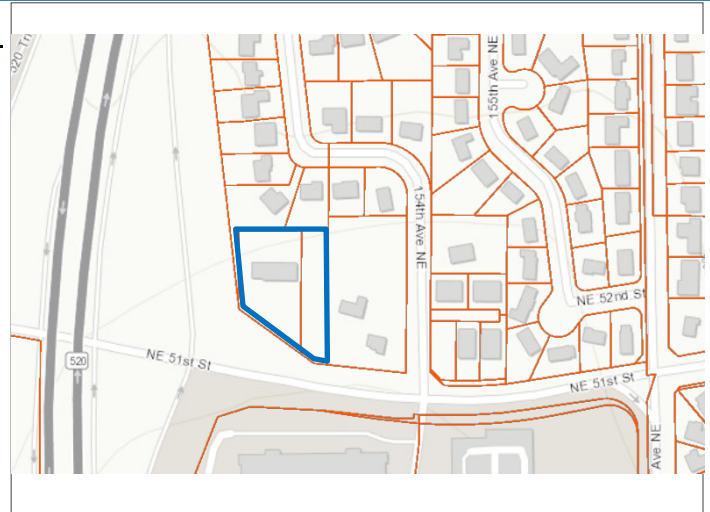

Preliminary Site Plan & Tree Preservation Plan

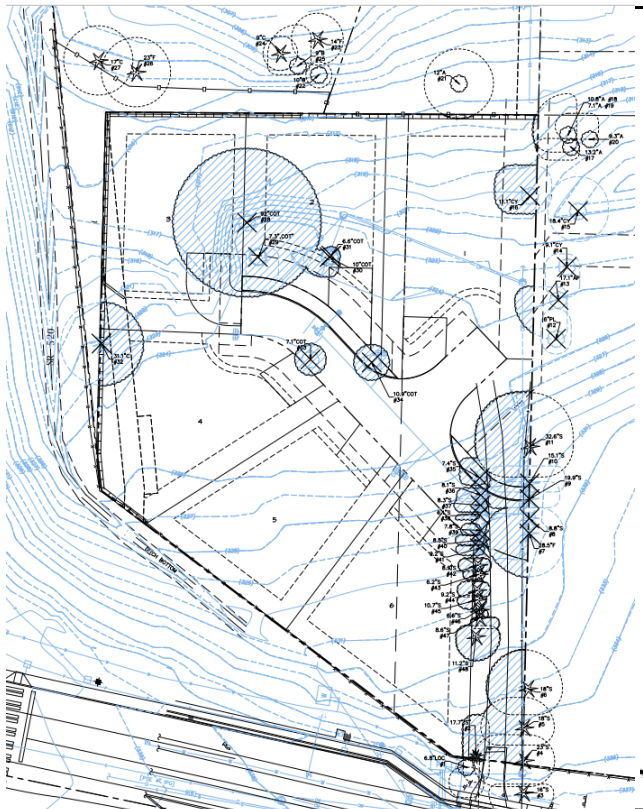

The Technical Committee shall not issue a decision until the end of the minimum comment period.
