

ORDINANCE NO. 2123

AN ORDINANCE OF THE CITY OF REDMOND, WASHINGTON, ADOPTING THE 2001 KING COUNTY COMPREHENSIVE SOLID WASTE MANAGEMENT PLAN AND REPEALING SECTION 1 OF ORDINANCE NO. 1754

WHEREAS, RCW 70.95.080 requires that each city develop its own comprehensive solid waste management plan, enter into agreement to prepare a joint city/county plan or authorize the county to prepare the plan for the City's solid waste management, and

WHEREAS, Ordinance No. 1555 of the City of Redmond, passed by the City Council on March 21, 1990, adopted King County's 1989 Comprehensive Solid Waste Management Plan, and

WHEREAS, Ordinance No. 1754 of the City of Redmond, passed by the City Council on December 7, 1993, adopted King County's 1992 Comprehensive Solid Waste Management Plan, and

WHEREAS, King County has prepared an update to the plan and has submitted it to the City for approval and adoption, NOW, THEREFORE,

THE CITY COUNCIL OF THE CITY OF REDMOND, WASHINGTON, DO
ORDAIN AS FOLLOWS:

Section 1. Adoption of Updated Plan. The City of Redmond hereby adopts the 2001 King County Comprehensive Solid Waste Management Plan, a copy of which shall be maintained in the Redmond City Clerk's office for inspection during regular business hours.

Section 2. Adoption of Prior Plan Repealed. Section 1 of Ordinance No. 1754 of the City of Redmond, passed by the City Council on December 7, 1993, and adopting the 1992 King County Comprehensive Solid Waste Management Plan, is hereby repealed.

Section 3 Severability. If any section, sentence, clause or phrase of this ordinance should be held to be invalid or unconstitutional by a court of competent jurisdiction, such invalidity or unconstitutionality shall not affect the validity or constitutionality of any other section, sentence, clause or phrase of this ordinance.

Section 4 Effective Date. This ordinance being an exercise of a power specifically delegated to the City legislative body, is not subject to referendum, and shall take effect five (5) days after passage and publication of an approved summary thereof consisting of the title.
